Pryme Successfully Completes Balance of Placement

HIGHLIGHTS

- **\$1.0 million raised through private placement**

Pryme Energy Limited (Pryme) is pleased to announce that it has raised \$987,000 through a private placement of 12.34 million new ordinary shares, at a price of \$0.08 per share (the Placement). The Placement represents the balance of the securities available and that can be issued under the Company's 15% issue capacity in accordance with ASX Listing Rule 7.1.

"The placement is the second and final part of an issue of shares we made in December 2012," said Justin Pettett, Pryme's Managing Director.

Use of Proceeds

Proceeds from the Placement will be utilised for general working capital requirements. Following the Placement Pryme's available cash balance is approximately \$3.1 million. The capital structure of Pryme post the Placement is as follows:
